First Class Diploma in Engineering (full time course) in the respective discipline with 60% marks from State Board of Technical Education/recognised Indian University (relaxed to 50% marks for SC/ST/PwD candidates and relaxation applicable for reserved posts only).

## II. AGE: 18-27 years as on 01.09.2023 (DOB between 01.09.1996 to 01.09.2005). Relaxation to reserved category candidates as per guidelines in this regard.

- III. RESERVATION OF VACANCIES:** Guidelines under the Apprentices Act on reservation for SC/ST/OBC will be followed. - IV. DURATION OF TRAINING:** The duration of Apprenticeship training will be for a period of one year as per Apprentices (Amendment) Act, 1973.
- V. PREVIOUS TRAINING EXPERIENCE:** Candidates who have already undergone or are currently undergoing apprenticeship under Apprenticeship (Amendment) Act, 1973, and/or having one year of experience are not eligible to apply.
- VI. SELECTION PROCEDURE:** Selection will be based on the marks obtained in the respective discipline qualifying exam and interview. The final merit list would be prepared according to categories General / SC / ST / OBC / PwD on the basis of marks obtained by the candidates through the interview process. Engagement for apprenticeship training will be subject to the selected candidates clearing the medical examination
