NOTICE FOR RECRUITMENT

The State Health & Family Welfare Society, Tripura is going to fill up different categories of post of Medical Officers, on contractual and fixed pay basis from the candidates who are permanent resident of Tripura, through Walk-in-Interview. The engagement will be initially for a period of 11 (eleven) months on contractual basis, which may be extended further based on performance till the completion of the project or subject to sanctioning of fund by the Ministry of Health & Family Welfare, Govt. of India. In exceptional cases the contractual appointment may be discontinued/terminated at any time without assigning any reason with 1(one) month's prior notice or 1 (one) month salary.

3. Application receiving system:

All application are to be received only through online (https://nhmjob.tripura.gov.in/) in the NHM Website Job Section. No application will be accepted through any other alternative routes i.e, hard copy/scan copy sending through e-mail or any other means. The online application submission will be available from 11:00 am of 15/01/2025 to 4:00 pm of 04 /02/2025.

4. Date, time & venue of the Walk- in-interview:

Walk-in-interview for each category of post will conducted in the O/o the MD, NHM, Tripura. Scheduled of the walk-in-interview will be communicated later on in the (http://tripuranrhm.gov.in) in due course of time.

5. Age relaxation limit:

40 years for UR candidates & 45 years for SC/ST candidates for all categories of post.

2. Candidates' selection criteria:

The candidates will be selected based on their merit on the basis with 50% weightage on Academic Performance Indicator (API) and rest 50% for interview/ viva-voce/ performance before the Interview Board by the candidate.

8. Norms for appearing the Walk-in-interview:

Interested eligible candidates are requested to appear before the Interview portal generated from the Board along Card with Admit https://nhmjob.tripura.gov.in/ and with all original documents uploaded during the filling up of the online application viz, (a) Copies of qualification (all Mark sheet) from Madhyamik onwards upto Graduation/ Post Graduation (as applicable as per the advt. criteria), (b) Valid Registration Certificate from Medical Council of India/ Central or State Council for MBBS/ BHMS/BAMS/BDS (c) Caste Certificate (for reserved categories), (d) Permanent Resident Certificate of Tripura (PRTC), (e) Age Proof (Madhyamik Admit Card)/ 10th Standard Board Admit Card), (f) Photo ID with address (Aadhar card/ Driving license/ Voter ID) (g) Disability certificate (if applied for vacancy against PH category), (h) Ex-service certificate (if applied for vacancy against PH category).

9. Instructions:

- Vacancies shall be subject to the State Reservation Policy of Tripura. Guideline and modalities for effecting reservation for the person with benchmark Disabilities will be followed. Horizontal reservation for women in the posts shall be applicable as per the policy notified by the State Government. Only those candidates having the Permanent Resident Certificate of Tripura (PRTC), issued by the Govt. of Tripura can apply for the post/s.
- 2. In the case of Cumulative Grade Point Average (CGPA)/Grade Point Average (GPA), applicants shall provide marks details in percentage at the time of filling the online application form and documentary proof for the basis of calculation of percentage shall be produced whenever it is required. If the applicant fails to present the above, supporting documents he/she shall be liable for the disqualification/ cancellation of his/her candidature.
- 3. T.A. & D.A. will not be admissible for appearing in the recruitment procedure.
- 4. The selected candidates will have to perform their duties for a minimum of 06 to 08 hours in a day.
- 5. Name of the short listed candidate will be published in the official website of NHM (http://tripuranrhm.gov.in/) in due course of time.
- 6. Any candidate against whom a criminal case is pending in any court or has been convicted by any court, such candidates are barred from applying in the above posts.
- 7. The decision of the competent authority of the State Health & Family Welfare Society, Tripura in any matter relating to the recruitment at any stage of the recruitment process will be final and binding upon the candidate.
- 8. If at any stage of recruitment, it is found that the candidate does not fulfil the eligibility criteria and/or that she/ he has furnished incorrect/ false information/ certificate/ documents or has suppressed any material fact(s), his/her candidature shall stand cancelled, apart from taking actions as per legal provisions.
- 9. The Mission Director, National Health Mission, Tripura shall have the right to suspend/ cancel any application/ entire recruitment process or a part thereof without showing any reason.
- 10. The Mission Director, National Health Mission, Tripura reserves the right to amend recruitment rules and process at any time of the selection. Any such

amendment shall be valid and binding on the candidates during the recruitment process.

- 11. Any legal dispute pertaining to the recruitment process shall be under the jurisdiction of the courts in Agartala, Tripura.
- 12. Further correspondence in this regard will be notified in the official website of NHM (http://tripuranrhm.gov.in) in due course of time.
- 13. Candidates already employed in any Govt./ Semi-Govt./Societies/ any other organization shall have to submit No Objection Certificate from their present employer while applying for the post and have to produce release order from their concerned employers while joining in the above mentioned post, failing which his/her candidature will be cancelled and the next eligible will be selected for filling up the vacant post.
- 14. The number of post may increase / decrease any point of time during the recruitment procedure or even the entire recruitment process may be cancelled anytime without assigning any reason.
- 15. Only a full-time course for the essential qualifications as required in the ToR/ Eligibility Criteria shall be considered valid.
